

His Excellency Abdullah Bin Hamad Al-Attiyah

President of the Administrative Control and Transparency Authority, Qatar

Born in the State of Qatar in 1952, H.E. Abdulla Bin Hamad Al-Attiyah has more than 30 years of experience in the oil and gas industry holding numerous senior positions in the Ministry of Finance & Petroleum and Ministry of Energy & Industry.

In September 1992, H.E. was appointed Minister of Energy and Industry, State of Qatar, Chairman of the Board of Directors and Managing Director of Qatar Petroleum. In 1998, H.E. was appointed Chairman of the Planning Council, in the State of Qatar, while retaining his other posts.

From January 1999 to April 2000 he was appointed as Minister of Energy, Industry, Electricity and Water. In September 2003, H.E. was appointed Second Deputy Premier, while retaining his post as Minister of Energy & Industry.

On April 3, 2007, H.E. was appointed Deputy Premier and Minister of Energy & Industry. On January 18, 2011 he was appointed Chairman of the Emiri Diwan, while retaining his post as Deputy Prime Minister.

On November 30, 2011 he was appointed President of the Administrative Control & Transparency Authority retaining his post as Deputy Prime Minister.

H.E. Al-Attiyah also holds the following positions:

- * Since 1975: Chairman, Gulf Helicopters Company
- * 1986 – 2002: Member, Gulf Air Board of Directors
- * Since 1992: Chairman, Qatar Amateur Radio Society
- * Since 1999: Chairman, Qatar General Electricity & Water Corp.

- * Since 2011: Member, Board of Trustees of Qatar Museums Authority

In May 2006 H.E. Al-Attiyah was elected as Chairman of the United Nations' Commission on Sustainable Development (CSD-15) for one year. He was awarded an Honorary Doctorate from Texas A&M University on May 5, 2011.

He has participated in numerous OPEC and OAPEC Ministerial Conferences and has been elected several times to preside over the OPEC Conferences. He has delivered various speeches/lectures in the field of energy and industry at many international and regional conferences.

He has been awarded the following order & medals:

* Her Majesty Queen Beatrix of the Netherlands has awarded him the Grand Cross in the Order of the Orange Nassau (2011)

* His Imperial Majesty the Emperor of Japan has awarded him the Grand Cordon Order of the Rising Sun in recognition of his great achievements and efforts in promoting and strengthening friendly relations and cooperation with Japan (2008).

* The Lebanese government has awarded him the following medals in recognition of his outstanding contributions in the academic field and in promotion of bilateral relations:

- The National Order of the Cedar (Grand Officer) in 2000
- Lebanon Order of Merit (1st Grade) in 2005
- Teaching Staff Medal for the Alumni of the Faculty of Engineering American University in Beirut (2006)

William F. Weld *Former Governor of Massachusetts*



Former Massachusetts Governor Bill Weld provides clients with advice and counsel related to government strategies, international business transactions, cross-border investments, and international capital flows.

Before joining ML Strategies, Bill practiced law in the New York and Washington, DC offices of a large international law firm, where he established an extensive international consulting business in energy, mining, and technology.

Bill was elected Governor of Massachusetts in 1990 and reelected in 1994 with 71% of the vote. During his term, he succeeded in reducing taxes while balancing the state budget, and his pro-business policies are widely considered to have made a positive impact on the state.

As Governor, Bill led sixteen official trade missions to Asia, Africa, Latin America, and Europe. He also served as national co-chair of the Privatization Council, which pioneered public-private partnerships, particularly in the area of infrastructure.

Bill has long experience in energy issues and markets. As Governor, he deregulated the electric industry, setting a model for other US states to introduce competition and market mechanisms. He mandated the use of natural gas as

fuel for government bus fleets, and was an early proponent of the development of hybrid and electric vehicles. More recently, Bill has spent a number of years working on oil and gas exploration and production and mining issues in emerging markets around the world.

Bill served as Assistant US Attorney General in charge of the Criminal Division of the Justice Department in Washington, and as US Attorney for Massachusetts, earning national recognition for his work fighting public corruption and white-collar crime. He also spent a dozen years practicing as a securities and anti-trust litigator. Earlier, Bill served as a staff member in both the US House of Representatives, where he participated in the Watergate impeachment inquiry, and the US Senate.

Bill is an active member of the Council on Foreign Relations in New York and Washington, DC.

Bill also serves as an associate member of the InterAction Council, a working society of former heads of state which convenes annually to consider and report on issues of global concern. The InterAction Council was hosted by King Abdullah of Saudi Arabia at a recent annual meeting, and will be convening in May 2013 in Bahrain.

HE Fuad Siniora *Former Prime Minister of Lebanon*




HE Mr Fuad Siniora is currently the Head of the Future Bloc in the Lebanese Parliament. He also served as the President of the Council of Ministers in Lebanon from 2005 to 2009. Prior to his Premiership Mr. Siniora served as the Minister of Finance between 2000 and 2004.

Mr Siniora was also the Chairman – Chief Executive Officer of the Méditerranée Group from 2004 to 2005 and served on the Board of Arab Bank. He was appointed as acting Minister of State for Financial Affairs in successive cabinets during H.E Rafic Hariri's tenure as Prime Minister between 1992 and 1998.

Between 1982 and 1992 Mr. Siniora held several high level executive posts within the Méditerranée Group. Mr. Siniora was also the Chairman – Managing Director of the IRAD, sal and Mal, sal Holding Companies and was a director at the Arab Universal Insurance & Reinsurance Co.

Mr Siniora began his career in the finance industry at Citibank in the early 1970s and then joined Lebanon's Central Bank in 1977 where he Chaired the Banking Control Commission until 1982.

During that time he also lectured the Lebanese University and at his alma mater, the American University of Beirut, where he earned a Masters degree in Business Administration in 1970.

His Excellency Abdullah Bin Hamad Al Attiyah has been a fixture on the international oil and gas scene for more than three decades. After graduating, he joined his Country's oil and gas industry where he very quickly made his mark, becoming a witness to and an engine for the transformation of Qatar into a major global player on the energy scene.

The combination of his quick wit and courage helped His Excellency Al Attiyah to encourage his country to take risks to build up its gas industry, with an enviable degree of success, including the creation of the world's largest liquefied natural gas company supplying consumers across the globe.

My own personal acquaintance with His Excellency Al Attiyah goes back almost three decades as, throughout the 1980's, we both continued our careers in the oil and gas industry and our paths regularly crossed at various OPEC meetings. When, in 1992, His Excellency Al Attiyah was given his Country's ministerial portfolio responsible for oil and gas, our encounters became more frequent as we met repeatedly at meetings of the OPEC Conference of Ministers. There were occasions when our points of view on matters under discussion did not always concur, but we were always united in our common desire to safeguard and advance the interests of our respective Countries, on the one hand, and the interests of the Organization of the Petroleum Exporting Countries, on the other.

On more than one occasion during the 1990s, His Excellency Al Attiyah and I shared the OPEC Presidency – in 1993, His Excellency Al Attiyah was President and I held the Alternate Presidency, in 1996 our roles were reversed. We also both served on OPEC's production monitoring committee during some of the most difficult years in OPEC's history. Over this time, I learned to respect and admire His Excellency Al Attiyah's professionalism, dedication, enthusiasm and, dare I say, genius for finding solutions to seemingly unbreakable deadlocks.

I know that, during his illustrious career, His Excellency Al Attiyah has received a number of awards and honours, including the Grand Cross of the Order of Orange Nassau by the Queen of the Netherlands and the Grand Cordon Order of the Rising Sun by the Emperor of Japan. More recently, His Excellency Al Attiyah received an Award from his own Head of State in recognition of his outstanding contribution to Qatar's commitment to transparency in business and governance and for his unrivalled contribution to Qatar's enviable economic progress.

For me to be considered a recipient of one of the first Abdullah Bin Hamad Al-Attiyah International Energy Awards is a humbling but indescribable honour. The lifetime achievements of His Excellency Al Attiyah makes an Award carrying his name all the more treasured.

I MET His Excellency Abdullah Al-Attiyah while covering one of the more difficult and drawn out OPEC ministerial closed sessions at the OPEC conference in Geneva in 1988. He was sitting in the hotel lobby chatting with his colleagues from other delegations.

He was then Director at the office of Qatar's Minister of Oil, where he played an essential role in and was closely associated with all the debates at OPEC.

I recall that His Excellency asked me my name and nationality, and thereafter briefed me on the politics and history of troubled Lebanon at that time, better than any Lebanese. And as I came to know him better, I discovered that he was an encyclopedia on the history and politics of all Arab countries.

In 1999, His Excellency was appointed Minister of Energy, Water and Electricity. His presence at OPEC conferences was essential for the success of the meetings; his negotiating and political skills, and deep knowledge of OPEC and its member countries made him instrumental in the success of OPEC conferences. HE Al Attiyah was also open to the press and often a valuable source to journalists who, in the early days of OPEC, did not have easy access to information at OPEC meetings.

His Excellency also successfully launched the gas industry of Qatar, which has become the biggest producer of LNG in the world. His personal relations with OPEC oil ministers, with international oil companies CEOs, with officials East and West, have made him renowned as an expert in the energy sector, respected for the transparency and authority with which he built the industry in his country.

Since his appointment in 2007 as Deputy Prime Minister with the energy Minister's portfolio, and in 2011 as Chairman of the Emiri Diwan, and in 2012 as President of the new Transparency Authority in Qatar, everybody in OPEC has missed him, from his fellow ministers to all in the international media – his smile is unique!

His Excellency's human qualities are significant. He has helped many former officials in the energy sector from different Arab countries which have witnessed upheavals, and has always recruited capable people from many other Arab countries to work with him.

He is loyal to his country, loyal to his friends, and is a humble and generous individual.

HIS EXCELLENCY Abdullah Bin Hamad Al-Attiyah is a visionary leader and a selfless servant of Qatar's goals for sustainable growth and development, and he is among Texas A&M University at Qatar's most ardent supporters.

Beginning in 1992, HE Minister Al-Attiyah concurrently held the positions of minister of energy and industry, and chairman and CEO of Qatar Petroleum. From those posts he led a revolution of the nation's energy industry by developing the market for liquefied natural gas (LNG). Now Qatar is the world's leading exporter of LNG — and is the world's wealthiest nation per capita.

When he was promoted to head the Amiri Diwan in 2011, he had been longest-serving OPEC oil minister, and he is known internationally as a leading authority on energy markets and industries. His wisdom, experience and insight continue to make him a valuable resource to the State of Qatar.

In spite of all this, HE Al-Attiyah remains a modest and straightforward man who saw tremendous value in educating Qatari nationals locally, and in particular, with the rapid growth in Qatar's economy, he anticipated the extraordinary demand for engineers. He recognized the need, also, for technical expertise to solve practical problems faced by Qatar's industry sector. As chairman of Qatar Petroleum, he had ties to every part of the nation's energy sector, which eagerly looked to Qatar-based researchers as a resource.

It should be no surprise then that HE Al-Attiyah is the genesis of Texas A&M University's campus in Qatar—it was his idea to approach the University about establishing a campus in Education City. Now, with the University in its tenth year in Qatar, his support for Texas A&M and engineering education in Qatar is as strong as ever. He is a role model and source of inspiration for our students, and Minister Al-Attiyah represents the finest example of a partner whose relationship with the University reaches all three pillars of our mission of teaching, research, and service. For this he was awarded an honorary doctorate by Texas A&M University in 2011.

HE Al-Attiyah realizes the tremendous value the University brings to Qatar, and he recognizes the ways our contributions to this proud nation enable its development and forward progress. He is steadfast in his belief that the University's relationship with Qatar is reciprocal and mutually beneficial.

In my ten-plus years associated with Texas A&M University's campus in Qatar, I have met few people who were as enthusiastic about the University's presence in the Middle East as Minister Al-Attiyah. And I have worked with nobody who was a stronger supporter of the University's academic, research and outreach programs in Qatar. His contributions to the State of Qatar are manifold, but perhaps it is his support for engineering education that will be longest enduring.

Lifetime Achievement for the Advancement of Future Energy Leaders

His Excellency Sheikh Nahayan Mubarak Al-Nahayan *Minister of Higher Education and Scientific Research, United Arab Emirates*

Sheikh Nahayan Mubarak Al-Nahayan's life and career have been characterized by creativity, innovation, and dedicated public service. In his role as the Minister of Higher Education and Scientific Research, he has guided and shaped higher education in the United Arab Emirates and has established a successful model for higher education throughout the Gulf region. He is the Chancellor of the United Arab Emirates University, the President of Zayed University and the Chancellor of the Higher Colleges of Technology in addition to his duties as the Minister of Higher Education and Scientific Research, all of the United Arab Emirates

Sheikh Nahayan is also a recognized leader in dealing with the major social and economic issues that impact the United Arab Emirates and the Arab region. He has played a major role in policy formulation related to the economic and social development of the United Arab Emirates. Sheikh Nahayan has chaired several cabinet committees on manpower planning and social development in the United Arab Emirates, committees charged with formulating policies for human and social development in the country. He is an accomplished public speaker. He gives more than 150 public speeches and presentations every year.

In private business, Sheikh Nahayan is an active, successful businessman, both within the United Arab Emirates and on the international stage. He heads the Abu Dhabi Group, one of the largest international investors in Pakistan, with interests in banking, tele-communications, pharmaceuticals,

construction, petrochemicals, hotels, and real estate. He is a chairman of the board of many important companies, including Chairman of the Union National Bank in the UAE, Founder and Chairman of Warid Communications, Founder of Bank Al-Falah, in addition to being the chairman of United Bank Limited.

A noted patron of the arts, Sheikh Nahayan strongly supports a wide range of activities, from natural history to music and culture, from national heritage to sports. He is a strong proponent of advanced technology and global best practices in education and business. An active philanthropist with a high sense of social responsibility, he champions many humanitarian causes and provides strong support for individuals with disabilities.

His Excellency Dr. Mohammed Bin Saleh Al-Sada

Minister of Energy and Industry, Qatar & Chairman of the Board of Qatar Petroleum

H.E. Dr. Mohammed Bin Saleh Al-Sada has been appointed as Qatar's Minister of Energy and Industry on 18 January 2011 and then named as the Managing Director and Chairman of the Board of Qatar Petroleum (QP) on 14 February 2011.

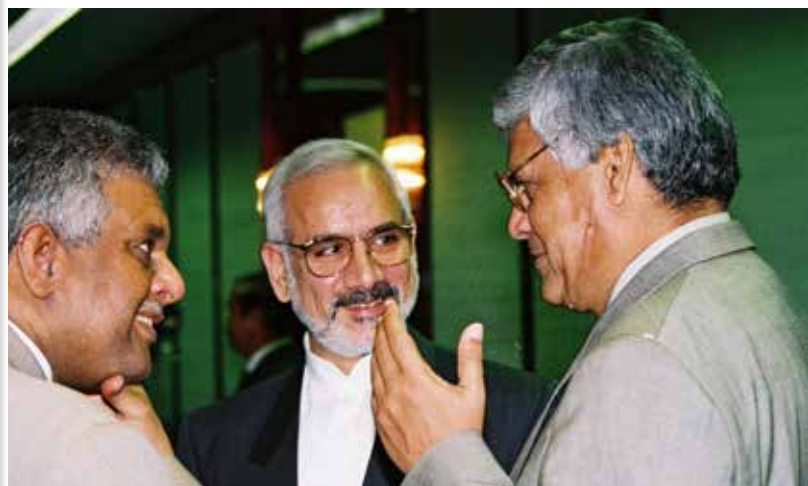
Prior to this, he was the Minister of State for Energy & Industry Affairs since April 2007, and he earlier served as the Managing Director of RasGas Company Limited (RasGas). Previously, H.E. Dr. Al-Sada held the position of Director Technical at QP, where he directed major oil & gas projects and related infrastructure projects. He brings with him a wealth of experience with over 28 years of service with QP, successfully managing various important corporate departments.

Within the energy industry, H.E. Dr. Al-Sada is the Chairman of the Board of RasGas, Qatargas, Qatar Chemical Company Ltd. (Q-Chem), Qatar International Petroleum Marketing Company Ltd. (TASWEEQ),

Qatar Petroleum International (QPI) and ASTAD Project Management, Industries Qatar, Gulf International Services. He is also the Vice-Chairman of the Board for Qatar Steel Company.

H.E. Dr. Al-Sada is an active member of the Qatari community and has served as a member of several distinguished committees and organizations, including the Permanent Constitution Preparation Committee, the Supreme Education Council and the National Committee for Human Rights. He is currently the Chairman of the Joint Advisory Board (JAB) of Texas A&M University at Qatar and a Board Member of the Qatar Foundation

His Excellency holds a PhD from the University of Manchester Institute of Science and Technology (UMIST) in the UK, having earlier graduated with a Bachelor of Science degree in Marine Science and Geology from Qatar University. He is married with two daughters and three sons.



Lifetime Achievement for the Advancement of OPEC

His Excellency Abdalla Salem El-Badri

OPEC Secretary General

HE Abdalla Salem El-Badri was appointed OPEC Secretary General on 1 January 2007. He began his oil industry career with Esso Standard (now ExxonMobil) in 1965 after studies in Accounting, Business Administration, Finance and Management in the United States and Libya.

In 1977, he became a member of the Board of Directors of Libya's Umm Al-Jawaby Oil Company, moving on to become Chairman of the Waha Oil Company (a joint venture company between the Libyan National Oil Company, Conoco, Amerada Hess and Marathon Oil) in 1980. In 1983, he became Chairman of the Libyan National Oil Company, before being made Minister of Petroleum in 1990. His ministerial career continued with his appointment as Minister of Energy, Oil and Electricity (1993-2000) and Deputy Prime Minister (2000-2004), before he returned to the chairmanship of the Libyan National Oil Company (2004-2006).

During the latter half of 1994, he was both President and Secretary General of OPEC, and again served as its president in 1996 and 1997. He has been a frequent speaker at numerous international industry events.



Lifetime Achievement for the Advancement of Education

Dr. Mark H. Weichold

Dean and CEO of Texas A&M University at Qatar

Dr. Mark H. Weichold is a professor of electrical engineering at Texas A&M University and has worked for General Dynamics Ft. Worth Division, Motorola in Austin, TX, and the U.S. Army Electronic Technology and Devices Laboratory in Ft. Monmouth, NJ. His research interests include electron device fabrication, process development, device design, and characterization. He has authored more than 80 journal articles, conference papers, and scientific reports, and holds three US Patents. He is a Senior member of IEEE and a member of the American Physical Society.

In 1998 at TAMU, he was appointed as the Associate Provost for Undergraduate Programs and Academic Services and later as the Dean of Undergraduate Programs and Associate Provost for Academic Services. In that capacity, he was part of a team whose work led to the establishment of Texas A&M University at Qatar in 2003. In January 2007, Dr. Weichold became dean and CEO of TAMUQ. Since then, Texas A&M at Qatar has grown to more than 500 currently enrolled students, including 40 graduate students, and nearly 80 full time faculty members. Of the 300+ graduates, nearly half are Qatari nationals. Texas A&M at Qatar is also home to a research program with more than 140 projects aligned closely

in support of the Qatar National Vision 2030 and involving collaborators from around the world.

Dr. Weichold joined the faculty at TAMU in 1982 and has been engaged in many aspects of engineering education over the past 30 years. He has developed a summer workshop lecture/demonstration for high school science teachers, hosts workshops for STEM teachers, and reaches out to high school students to encourage their pursuit of engineering and scientific fields. He has served as a program evaluator for ABET and has been involved with the preparation for TAMU/TAMUQ visits for over 20 years. As a faculty member, he has been part of academic and curricular leadership at the department, college, and university levels. He currently serves on the Qatar Foundation Academic Bridge Program Board of Governors and has served on the Board for the Community College of Qatar. Dr. Weichold is engaged with the Habib University Foundation in Pakistan to establish the Habib University and currently serves on its Board of Governors. He has shared his engineering education expertise at conferences in Chicago, Sedona, Abu Dhabi, Dhahran, Vancouver, and Singapore. In January 2013, he served as the General Chairman of the World Congress on Engineering Education in Doha.



Lifetime Achievement for the Advancement of Energy Journalism

Ms. Takieddine graduated in Political Science from the American University of Beirut in 1972. Her career in journalism started at the Daily Star newspaper in Lebanon.

She moved to Paris one year before the outbreak of the Lebanese civil war, where she worked as a freelancer with a number of French publications, including “Politique Internationale” for whom she interviewed King Hussein Of Jordan , Yasser Arafat and Muammar Gaddafi.

Ms Takieddine began her coverage of the energy industry on the newsletter “Al-Nahar Arab Report” - published jointly by Lebanese economist Marwan Iskandar and the Al – Nahar Lebanese publishing group. It was in this capacity that she reported on the first OPEC meeting in Caracas, Venezuela in 1977, and has since extensively covered the oil industry from Algeria to the Gulf.

In 1990, Ms. Takieddine was appointed as Paris correspondent for the Arabic language Al-Hayat newspaper, covering energy matters and French and Middle Eastern politics.

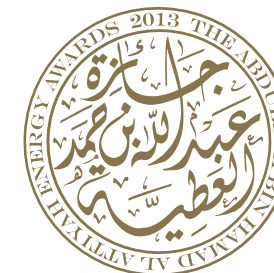
